I.T. BYTES! BEWARE OF PHISHING/SCAMMERS!



In this day and age scammers are targeting more and more people over the phone, pretending to be government officials. They tend to focus on older adults and pretend to be from places such as the IRS, Social Security, Medicare or even law enforcement. Remember, no government organization will ever call you demanding payment or request personal information. This form of scam is called Phishing, pronounced fishing, and defrauds Americans of hundreds of millions of dollars each year.

They make claims like if payment isn't made you will lose things such as your Social Security or Medicare benefits, that you could be arrested or deported or worse. Their numbers may even look like they are coming from an actual government number as they have technology called "spoofing" that allows them to pretend to call from any number they want.

One of the things they do is ask for personal information to "confirm" you are you, things such as social security number, birth dates, Medicare numbers and more. This information, once given is used to steal your identity and then used to open things in your name, leaving you responsible for them. Things such as loans, credit cards, purchases and at times even using the information to redirect your payments from Social Security and Medicare to themselves.

So, if you ever get a call demanding payment from anyone claiming to be from a government agency and it isn't through the agency's official site, but instead through a secondary payment form like gift cards, wire transfer or even bitcoin, it is a scam. Never give personal information over the phone to anyone that calls and demands it and never make payments to a stranger calling and claiming you owe money. Remember, their demands and threats hold no power and if it is a legitimate government agency or law enforcement, you should be able to get the same information from their website.
